The expressed intention of NMA Region III & Region V is to ensure that participating companies receive the highest level of recognition in return for their generous support.

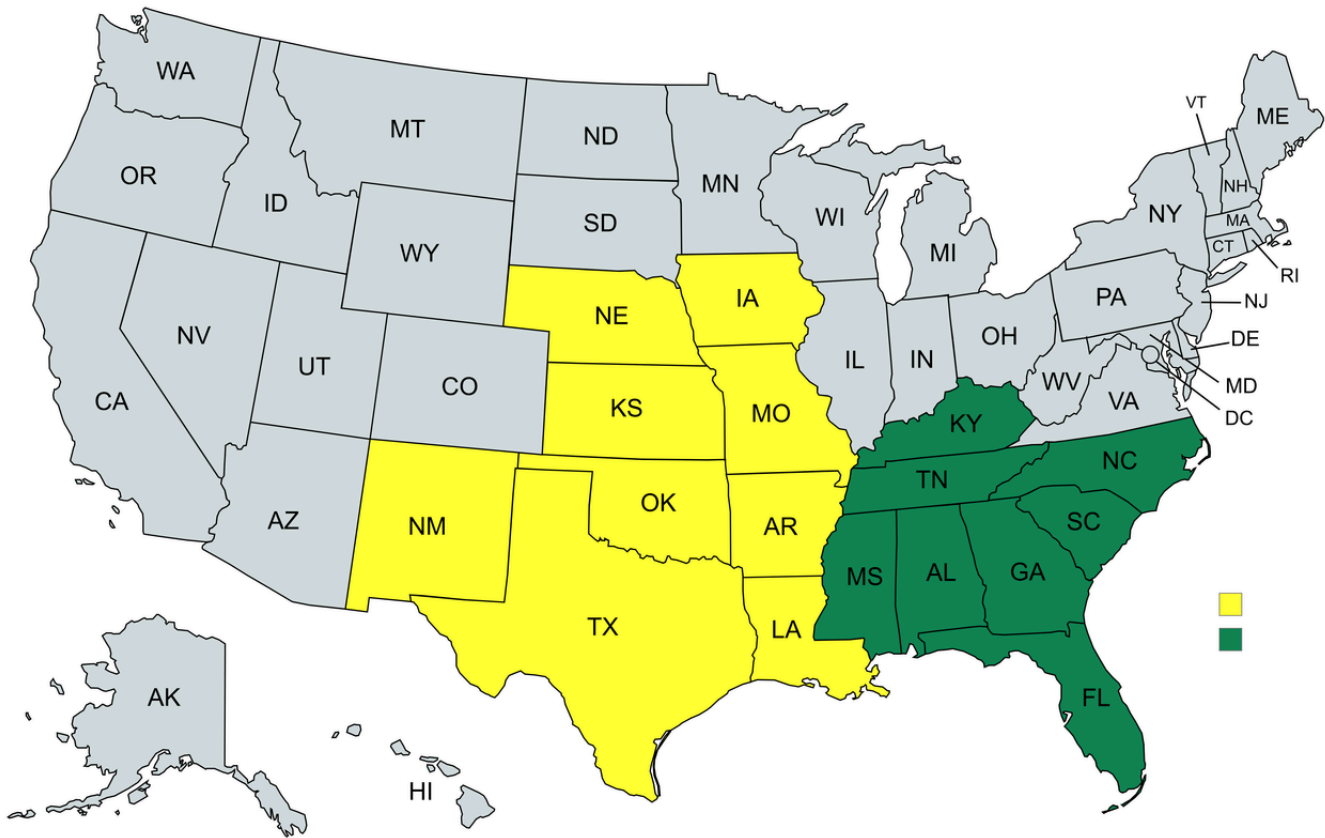

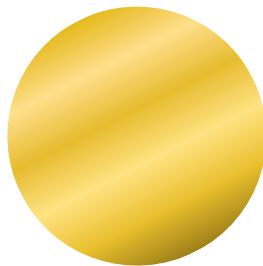
Nothing shall be posted on, nailed, screwed, or otherwise attached to columns, walls, floors, furniture, or other parts of the building.

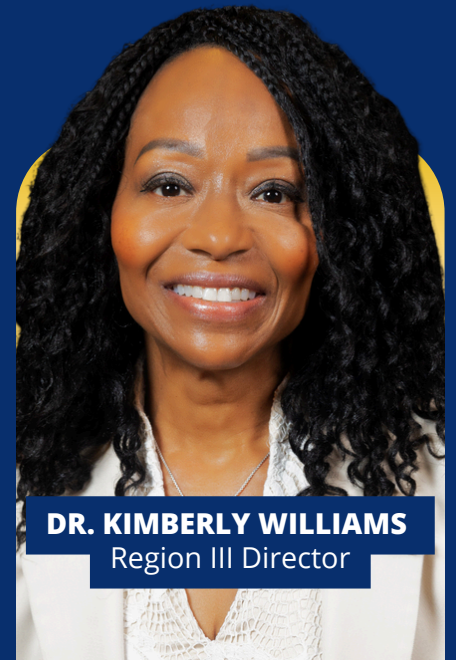
