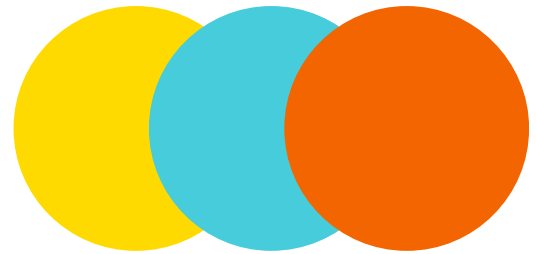
2024 NMA REGION V ANNUAL CONFERENCE
